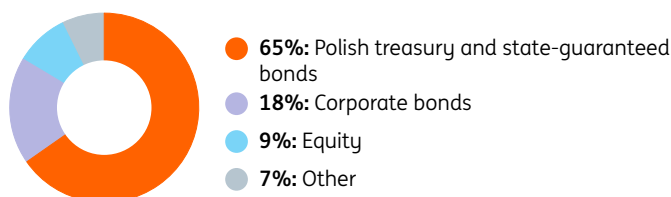
What should you know at the start?

Who is this fund for?

This subfund is for people who:

- expect returns higher than those from bank deposits,
- accept the low risk class of the subfund,
- accept value fluctuations and the possibility of losing part of the invested funds.

Risk

What should you keep in mind?

- Recommended holding period:** plan your investment for **at least 2 years** to give the fund time to go through better and worse periods in the market.
- Impact of interest rates:** the fund invests mainly in the bond market, whose prices are sensitive to changes in interest rates. If interest rates rise, bond prices may fall, which may reduce the value of your investment - and vice versa.
- Impact of the market situation:** the fund's performance is affected by both interest rate changes (important for the debt part) and the general economic situation, to which equity prices are sensitive. Deterioration of market sentiment or an economic slowdown may periodically reduce the value of the investment.

Check if this fund is right for you

- This fund will support the achievement of your retirement goals:** this is a **target date subfund**, created for PPK participants. It is intended for people born between 1963 and 1967.
- It is highly diversified:** it combines different asset classes - it invests both directly in shares and bonds, and through other Polish and foreign funds. Thanks to this, the funds of PPK participants work in many markets simultaneously, and the risk is spread.
- It changes over time:** the subfund has already reached its target date (2025), which is why low-risk investments (e.g., bonds) play a dominant role in it. However, the fund can still invest part of its assets in equity markets to maintain higher growth potential.

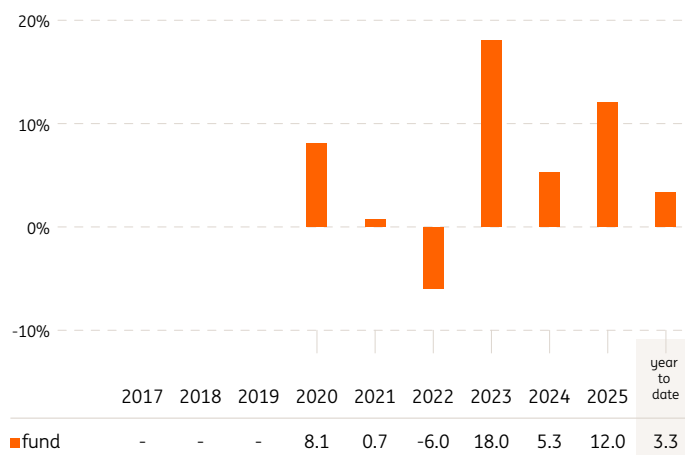

How do we manage?

- Emerytura subfunds are so-called target date subfunds created for the needs of Employee Capital Plans (PPK) participants. The share of what they invest in changes gradually over time. The longer until the date specified in the name of the subfunds, the greater the weight played by equity instruments (e.g. shares). Over time, their share decreases in favor of debt instruments (e.g. bonds),
- at the beginning of the subfund's operations, we invested up to 35% of its assets in equity instruments. As we approach the target date (2025) and after it, we will invest up to 100% of assets in debt instruments,
- we invest in debt and equity instruments both directly and through other Polish and foreign funds,
- under the rules specified in the prospectus, we can also invest in other financial instruments, including derivative instruments,
- the proportions between debt and equity instruments will change gradually. We will not make them dependent on the current and forecasted situation in the markets. What matters is how much time is left to reach the date specified in the name of the subfund,
- the subfund is actively managed and does not have a benchmark.

Fees in funds – what to keep in mind?

1. Pay attention to ongoing charges

Ongoing charges (as defined in the KID) include various categories of costs borne by the fund. These include management fees and other administrative or operating costs.

2. Fund performance shown in this factsheet is net of fees

Management fees, performance fees (if applicable) and administrative costs are already included in the price of the fund unit.

3. Performance fee is charged only when the fund performs well

If the fund has a performance fee, it is charged only when the fund's return exceeds a defined benchmark and after additional conditions are met.

4. Fees matter, but there is more

Fees reduce the value of your investment, so generally the lower they are, the better. However, this is not the only factor. The quality of management, consistency of results and selecting a fund that fits the investor's needs are equally important.

Additional information

Benchmark

A benchmark is a reference point used to assess whether the fund performs better, worse or in line with the market. It can be, for example, a stock index, bond yield or a combination of both.

Average annual rate of return for the last 5 years

This shows the fund's average return for each year over the last 5 years, taking into account the effect of compound interest. This reflects the actual investment outcome. For example, if the fund lost –5% in one year and gained +15% in the next, the arithmetic average is +5%, but the annualised return would be around +4.6% per year.

Additional portfolio exposure

Some funds may use transactions that allow them to invest more than the assets they hold. This is done to improve the risk-return profile. A common technique is sell-buy back, which works similarly to a secured loan. One party (the fund) receives cash from another financial institution, with securities used as collateral. The fund agrees to repurchase these securities at a specified time and price. The funds obtained can then be reinvested. If the fund uses such additional portfolio exposure, it will be shown below the “what does the fund invest in” table.
